**AMENDMENT TO AMENDED AND RESTATED DECLARATION
OF COVENANTS, CONDITIONS, RESTRICTIONS AND DEDICATION
OF EASEMENTS OF FOXBOROUGH HOMES ASSOCIATION, INC.**

THIS AMENDMENT is made this 17TH day of JUNE, 2015 by the undersigned members of Foxborough Homes Association, Inc. (hereinafter referred to as "Association").

WITNESSETH:

WHEREAS, on February 24, 1984, Saul Ellis and Company, Inc., a Kansas corporation ("Declarant"), filed that certain Declaration, recorded in Records of the Register of Deeds of Johnson County, Kansas, which was Amended and Restated on July 21, 2010 in Book 201007 at Page 006334 for the following described property ("Declaration"); and

WHEREAS, pursuant to Article XI of the Declaration, the Declaration may be amended at any time by written consent of Owners representing 60 percent of the total lots of the Association; and

WHEREAS, the Board of Directors has proposed to amend the Declaration to update the method of community governance, to establish a flexible and reasonable procedure to govern owners of residential units; and

WHEREAS, the undersigned owners, being more than 60 percent of the total Owners in the Association, consent to amend the Declaration stated below hereto; and

NOW, THEREFORE, the Declaration as amended is hereby amended by inserting the following into Article VIII:

WHEREAS, the Declaration at Article VIII requires Owners to seek approval from the Association prior to any exterior changes and improvements (hereafter "Improvements"); and

WHEREAS, on occasion, Owners within the community have completed construction of Improvements without first obtaining approval from the Association; and

WHEREAS, on occasion, the final Improvements do not comply with the approved project plan; and

WHEREAS, the existing policy regarding enforcement of Covenants does not adequately protect the Association in situations in which the Owner fails to obtain approval of the Improvements prior to commencing construction or the final Improvements do not comply with the approved plans.

NOW, THEREFORE, be it resolved as follows:

The Association hereby adopts a Policy as follows:

1. Reporting Violations: Complaints regarding construction of Improvements prior to obtaining approval may be reported by an Owner or resident within the community, to the Association's management company, if any, or to Board member(s) by submission of a written complaint.
2. Investigation: Such complaint shall be forwarded to the Board of Directors to determine if the Owner of the Lot submitted plans for approval and if the plans for the Improvement were approved.
3. Determination: In the event the Board of Directors determines the Improvement was not approved or if the final Improvements do not match the approved plans, the Association shall send a letter to the Owner indicating the alleged violation and notify the homeowner that the approval forms must be completed.
4. Fines: The fine for not submitting an application to the Board of Directors prior to the start of construction is \$500.00 payable within 30 days. A fine of \$200.00 will be levied if Improvements do not comply with submitted and approved plans. The fine of \$200.00 will be levied monthly until non-compliant Improvement is rectified. If the fine is not paid within 30 days, a lien will be filed against the lot and the homeowner will be responsible for all fees involved, including costs of collection.

5. Appeals: The homeowner shall have the right to appeal the decision of the Board of Directors. The appeal process is as follows:
 - a. Within 15 days of the date that the homeowner is notified of a fine, the owner must submit the appeal in writing.
 - b. The homeowner may attend the meeting to discuss the appeal.
 - c. If, after the decision, the homeowner fails to pay the fine and comply with the guidelines, the Association may elect to file a lien against the property and the homeowner will be responsible for all fees involved.

6. Final Approval: Authority for approval of any exterior construction, additions, painting, fence, wall or any other structure rests with the Board of Directors. If the completed project does not comply with the approved project, it is up to the Board of Directors to determine if the standards have been met. If the standards have not been met, a revision or removal of the project may be necessary at the sole expense of the homeowner.

7. Other Remedies: Notwithstanding anything to the contrary in this Declaration, the Association, through its Board of Directors, may elect to enforce any provision of the Declaration, the Bylaws or Rules and Regulations, or by suit at law or in equity to enjoin any violation or to recover monetary damages or both without the necessity of compliance with procedures set forth in this Declaration, and for any such action, to the maximum extent permissible, the owner or occupant responsible for the violation of which abatement is sought shall pay all costs, including reasonable attorney fees actually incurred.
